#### **CORONAVIRUS RESPONSE**

The Board's priority is to ensure all staff members are well protected, while at the same time ensuring our essential services continue.

Currently, the status quo is:

- ⇒ Our public safety security provider, Grit, is following internal protocols to protect staff.
- ⇒ All MID cleaning staff have been provided with masks, sanitizers and gloves, and have been instructed to take their lunch breaks in open air.
- ⇒ We have put out an urgent appeal for a temporary space from which the MID cleaning staff can operate. The cleaning staff are currently operating from the MID office, which is located directly next to the Muizenberg Clinic. To access the office, they must go through the waiting room filled with sick people, which places them at high risk. As such, we are appealing to the Muizenberg community to either donate, or offer a reasonable rental rate for a temporary space, such as a storeroom or garage. If you do have somewhere to offer, please phone the MID manager Michael on either 0824631525 or 0780148276, or email him on ops@mid.org.za. We need to make a decision on this by 23 March!
- ⇒ As per the above, the MID manager will move to the office of one of our directors, who has volunteered the space at no charge.

We have received several suggestions from the community on preparing for this crisis. We are grateful for this input and offers of collaboration. The Board is, of course, restricted in terms of what we can use the MID budget for and also cannot overlap with the services already provided by

- ⇒ Restaurants may continue normal trading hours, provided they do NOT sell liquor after 6pm.
- ⇒ All establishments (restaurants, bars, clubs, liquor stores) may not sell liquor after 6pm.
- ⇒ The CoCT has closed certain public spaces, including:

As many of you may be aware, there is currently a City of Cape Town proposal for 79 informal bays to be dotted in and around Muizenberg, including 40 trading bays in Atlantic Road alone.

After seeing this draft proposal, MID immediately approached the CoCT regarding a public meeting. We eventually received information that an "Open Day" would be held on Friday 27th March 2020 from 17:00 to 20:00 at the Muizenberg Civic Centre.

Following President Cyril Ramaphosa's ban on gatherings on 100 people or more, MID wrote to council requesting a postponement of the meeting and an extension of the public comment period. The City has agreed to postpone the meeting, but is insisting on the comment period deadline remaining as close of business on 31 March 2020. However, the City has indicated that it will include comments/objections after a public meeting at a later stage (please see correspondence further below).
