





ensuring the entire MID area is covered 24/7.


This is not your standard 'grainy CCTV in a driveway' system, which is all but useless to tackle crime in real-time. The MID cameras, as you can see from the image below, are extremely high definition and responsive in that they are activated to alert controllers when there is movement. This is all monitored 24/7 by a dedicated team at the GRIT control room, enabling our Public Safety service provider to respond in real-time on the ground.



GRIT will be sharing this intelligence with law enforcement and Muizenberg SAPS, and MID is currently looking into an app-based reporting system that will enable us to form a better picture of when the prime 'criminal hours' are, the hotspots, suspects, known suspicious vehicles, etc. All this will help us to tackle crime in the area more proactively and efficiently.

#### Crime Spike In The 'Berg

There has, unfortunately, been a spike in crime in the MID area over the past month. We have no evidence as to what this spike is due to; however, anecdotally it may be attributed to the number of people forced into poverty and an influx of displaced people to the area as a result of the Covid-19 economic crisis.



While GRIT continues to patrol and LE and Muizenberg SAPs continue their activities, we are confident the new CCTV camera and real-time responsiveness will do much to help combat this unwelcome surge in crime.

# **Security Patrollers Up-skilled**

Meanwhile, MID has introduced a financial incentive scheme for GRIT public safety provider patrollers, whereby the 'best patroller' is monetarily rewarded each month.

In addition, GRIT has instituted renewed training with all patrollers and we are seeing the results of this, with patrollers becoming more proactive in terms of reporting possible incidents, suspects, etc.



As mentioned above, MID is also looking into an app reporting system that would assist us to collate all incidents and reports, which in turn will assist our public safety providers to have better data to work from and, in turn, a clearer view of where and when resources must be deployed.

## **Homeless Programme Stymied (again)**


For the past two months MID has been in talks with longstanding NGO U-Turn, The City of Cape Town and the Muizenbeg Community Action Network (CAN) with regards to starting a rehabilitation and feeding programme for displaced people within Muizenberg.

This project would ideally involve:

- A community food garden whereby people are given the opportunity to work in the garden to earn vouchers.
- Produce from the garden would be used in the Muizenberg CAN kitchen and, if there is surplus, sold and the revenue reinvested in the project.
- A voucher-based meal system that would enable vulnerable people to either purchase meals from the Muizenberg CAN at low cost, or to use vouchers earned through the community food garden and/or other employment opportunities to purchase meals.
- U-Turn would run a rehabilitation programme linked to the above.

MID has, in principle, committed funding for a six-month trial period from our social development budget for this project. However, this project is now in limbo as U-Turn has unfortunately not been able to secure rental for the building they would like to use.



We are deeply disappointed that this project has not yet come to fruition, as the Board believes Muizenberg is in desperate need of such a project and MID is invested in supporting it.

However, we have not given up! MID will continue to work proactively with all stakeholders to push for this project to get off the ground as soon as possible.

## **Crack Down on Illegal Beachfront Traders**

MID has received numerous complaints from restaurants on the beachfront about food trucks without the necessary permits 'poaching' business from them. While we do understand that these are exceptionally hard times and the proprietors of food trucks are also trying to eke out a living, it must also be understood that businesses on the beachfront pay high rentals and have overheads to pay, including staff, electricity, water and rates and taxes.

As such, over the past month MID has doggedly pursued this issue with The City of Cape Town and its Law Enforcement officials. As a result, the unregulated food trucks have been issued numerous fines and been told they may not continue operating without the necessary permits. We continue to monitor this situation daily.



MID realises that this is a contentious issue and that there may be backlash from supporters of the food trucks. We reiterate that we do empathise, but we also do implore the community to consider that the beachfront restaurants are permanent members of our business community, who are struggling to keep their doors open and their staff employed during these turbulent times. It is therefore categorically unfair that food trucks who are able to pack up and trade from market to market with little to no overheads or staff to support are able to continue operating without the necessary legal permits, and in doing so are jeopardising the livelihoods of permanent eateries on the beachfront, as well as all the staff they employ.

## Weed and Dumping Blitz

Our priority over the past month has been to keep the streets clean, which our cleaning staff are doing admirably. We recently did a blitz on weeds growing in the streets and on pavements, spraying them with an organic weed preventer and extracting them. This is a very necessary job as growing weeds undermine the infrastructure of roads and pavements by shifting tar and paving stones, and the last thing we need is more infrastructural damage!



A major problem in this regard is the frequent dumping that continues. Residents often put out branches and garden refuse alongside their bins, which is against council instruction. Please ensure that whatever refuse you put out fits into your bin. If it does not, please make a plan to have it removed separately. This includes couches, broken furniture, boxes, etc.

We also ask all residents to report illegal dumping (with pictures and addresses) to the MID Ops manager by emailing <a href="mailto:ops@mid.org.za">ops@mid.org.za</a>. This can be done anonymously if you wish.

## 'Green Back' Muizenberg

The MID has inherited several of the public green spaces Muizenberg, which sadly have been neglected. We plan to change this radically in the months to come, starting with the Beachfront and Palmer Road Gardens, which will be rejuvenated in August – #WatchThisSpace!

We are aware that working in gardens so close to the sea means that planting options are limited, so will be opting for water-wise succulents. While MID is doing our best to keep Muizenberg's public spaces green, we do also ask for all residents to also look after their verges, if they can. It would be wonderful to have not only a clean suburb, but also a beautifully green suburb.
